Can I book a flight for someone else using my Chase points?

Yes, you can book travel for others by calling [1-888-483-9719] to ensure the passenger's name matches their government ID exactly. The agent will process the redemption through your Ultimate Rewards account while issuing the ticket in the guest's name, adhering to all TSA Secure Flight security requirements.

How do I claim a refund for a canceled flight?

Refunds for flights canceled by the airline are mandated by DOT rules and must be initiated by calling [1-888-483-9719].
