The Georgia Ports Authority will receive sealed bids for the Colonel's Island Terminal North Yard Improvements Phase 2 project located in Brunswick, Georgia.

Bids for proposed work will be received up to **1:00 PM, January 13<sup>th</sup>, 2026**. The bid opening will be public.

The proposed work consists of uniformly raising the elevation of the existing 26-acre concrete parking lot by approximately 3 feet. Work includes breaking and processing the existing concrete pavement in place, placing structural fill to achieve the required elevation, constructing Fabriflorm slope protection along the perimeter tie-ins, installing new asphalt pavement over the raised site, applying pavement striping, and implementing all required erosion and sediment control measures, including ongoing monitoring.
