A Powerful Gateway to Global Markets

- The Appalachian Regional Port (ARP) offers an **efficient solution** to hours-of-service/drive time challenges.
- Daily CSX service on a **direct, 388-mile rail route** to/from GPA's Garden City Terminal.
- Provides an **alternative to an all-truck dray** to/from the deepwater Port of Savannah for target markets in Georgia, Alabama, Tennessee and Kentucky.
- Each round-trip container moved via rail to the ARP **offsets 710 truck miles** on Georgia highways and keeps trucks and emissions off Atlanta highways.
- Located in Northwest Georgia, with **easy access to Interstate 75 and U.S. 411**. Easily serves the production and export of carpet and flooring, automobiles, tires, and other goods.
- Capacity: **75,000 containers**. Can increase upon demand.

Cargo Owners

- Contact ocean carriers for through bills of lading to/from ARP.

Motor Carriers

- **TWIC card not required** for entry. Drivers and trucking firms must register and comply with, intermodal interchange guidelines (UIIA).
- **On-site staff of 14** to assist drivers.
- Chassis Pool and M&R services at near-terminal site.
- **Designated start/stop site** for South Atlantic Chassis Pool.
- Designated **GPA-operated container yard** on site.
- Georgia has a legal gross vehicle weight (GVW) of 80,000 lbs (36,287 kg). With permits and proper chassis, GVW can increase to 100,000 lbs (45,359 kg).

Visibility

- Full visibility into cargo loading to rail, arrival at ARP or Savannah, and availability for pick-up via **webaccess.gaports.com**
